ORDINANCE NO. 375, 2006

**AN ORDINANCE**

**AMENDING ARTICLE III SECTION 130.055 AS AMENDED "CONTRACTS AND AGREEMENTS-BIDS AN APPROVAL REQUIRED" BY REPEALING SECTION 130.055 AND ENACTING IN LIEU THEREOF A NEW SECTION 130.055 PERTAINING TO CONTRACTS AND AGREEMENTS-BIDS AN APPROVAL REQUIRED.**

BE IT ORDAINED BY THE VILLAGE OF UPLANDS PARK BOARD OF TRUSTEES, OF THE VILLAGE OF UPLANDS PARK, MISSOURI AS FOLLOWS:

SECTION 1. Article III, Section 130.055 of the Municipal Code of the Village of Uplands Park "Contracts and Agreements-Bids and Approval Required" is amended by repealing therefrom Section 130:055 and enacting in lieu thereof the following:

**SECTION 130.055: CONTRACTS AND AGREEMENTS\_BIDS AND APPROVAL REQUIRED**

1. No contract or agreement which shall obligate the Village of Uplands Park, Missouri, in any manner, in sum to exceed seven hundred and fifty dollars (\$750.00), shall be entered into or executed by any officer of said Village, either elected or appointed, or by any other employee of the Village without without the Village first having received three three (3) written bids and thereafter, by the affirmative vote of the Board of Trustees of said Village approving same.
2. In the event of a natural disaster or emergency in which for the public welfare of said Village requires the Village of Uplands Park to secure work to be performed for the public welfare concerning a response to a natural disaster or emergency that causes damage or threatens to cause damage to the general welfare of the Village of Uplands Park Chairperson of the Board of Trustees of the Village of Uplands Park is authorized to obligate said Village by executing an agreement without first obtaining three (3) bids sums not in excess of seven hundred and fifty dollars (\$750.00) the Chairperson is and report such obligation of the Village to the Board of Trustees at the next regularly scheduled or specially called meeting of the Board of Trustees.
3. In the event of a natural disaster or emergency in which for the public welfare of said Village requires the Village of Uplands Park to secure work to be performed for the

public welfare concerning a response to a natural disaster or emergency that causes damage or threatens to cause damage to the general welfare of the Village of Uplands Park sums over the amount of seven hundred and fifty dollars (\$750.00) and not in excess of sum to exceed seven thousand dollars (7,000.00) may be entered into by the Village of Uplands Park Chairperson of the Board of Trustees of the Village of Uplands Park who is authorized to obligate said Village by executing an agreement without first obtaining three (3) bids only after by the affirmative vote of the Board of Trustees of said Village approving same.
