## September 22, 2010 Special Board Meeting Public Hearing Tax Rate

### **CALL TO ORDER:**

Chairman Williams called the special board meeting for the public hearing on the tax rate to order at 5:26 p.m.

### **ROLL CALL:**

Trustees Martin, McClendon-Roberts, and the chairman. Also present is the Village Clerk Charlotte Graham. Absent is Trustee Iwenofu who has no excuse for attending the meeting. Trustee Gamble is no longer on the board he resigned.

### **TAX RATE 2010:**

Chairman Williams said there are three copies, which will be sent to various locations. The tax rate levy is still the same. Resident 0.3260, agriculture 0.000, commercial 0.4080, and personal property tax 0.3910 for 2009. He suggested leaving everything the same. He asked the board members if there were any questions, and entertained discussion. Trustee McClendon-Roberts said the taxes are sealed at .50 per hundred. Which have the option to decrease in finances? She suggested to raise the taxes to .37 per hundred. The chairman said that's good. The year before the tax rates were rolled back in 2008. Trustee Martin suggested also increasing the tax rate. Chairman Williams said the tax rate is due October 1<sup>st</sup>. Trustee McClendon-Roberts said she oppose the tax rate to increase. Taxes have failed dramatically. Trustee Martin motioned to increase the tax rate to .37 cents per hundred. Seconded by Trustee McClendon-Roberts. Roll Call; Trustees Martin-yes, McClendon-Roberts-yes, and Chairman Williams-yes. Motion Carried. Trustee McClendon-Roberts said per personal property related to what is paid into the village be moved up to .45 cents. Trustee McClendon-Roberts motioned to increase up to .45 cents for personal property. Seconded by Trustee Martin. Roll Call; Trustees McClendon-Roberts-yes, Martin-yes, and Chairman Williams yes. Motion Carried. Chairman Williams said the tax rate for commercial is set by St. Louis County.

### **MOTION FOR ADJOURNMENT:**

Trustee McClendon-Roberts motioned for the special board meeting to be adjourned. Seconded by Trustee Martin. All in favor; Motion Carried. The meeting is adjourned at 5:40 p.m.
