SECTION II: The Clerk of St. Louis County, Missouri, and the Revenue Department thereof, is hereby authorized to extend on the books of the Collector the amount of the taxes due and collectible according to the above rate on all (Real Estate, Personal and Mixed) property within the corporate limits of the VILLAGE of UPLANDS PARK, Missouri.

SECTION III: The Collector for the VILLAGE of UPLANDS PARK is directed to obtain from the County Clerk of St. Louis County, Missouri, the necessary (Real Estate, Personal, and Mixed) property tax abstracts for the purpose of extension, billing and collecting said extended taxes at his office, and the collection of all taxes so extended shall be enforced in the same manner and under the same rules and regulations as may be provided by law for collecting and enforcing the payment of state and county taxes.
